## Convention Delegates and the Work of the Union

On March 21, 2011, Local 571 successfully amended its Constitution and Bylaws at the biennial Constitutional Convention. 50 delegates voted on adopting the changes that affect the membership of the Local.

During the fall, the Constitution and Bylaws Committee, chaired by 571 Financial Secretary Jon Pazol, met to review potential amendments. Although there were only seven proposed changes this year, the committee met several times to ensure there was continuity between the changes and the entire document. The Local 571 officers and staff also met to provide assistance on appropriate wording. Draft amendments were shared with the WSTU Executive Board, which made final recommendations. All of the registered delegates were provided with the proposals one month prior to the Convention.

Local 571 Vice President Alice Kautsky chaired the Convention Committee. Committee members planned the logistics of the Convention, including registering and certifying delegates, coordinating dinner, and providing Convention materials. They were also charged with ensuring that *Robert's Rules of Order* was used during the proceedings and that a Parliamentarian was present to provide assistance to the local officers both before and during the Convention.

The 2011 changes in the Local 571 Constitution and Bylaws adopted at the Convention included:

- 1) the addition of an 1/8 member category for those members who make less than \$8,500 per year, in accordance with AFT and IFT changes.
- 2) the adjustment of the 1/2 and 1/4 dues categories to reflect yearly salary earnings.
- 3) updated council dues, if applicable, for each council.
- 4) moving the first House of Representatives meeting of the school year from September to August to reflect changes in districts' school calendars.
- 5) adjusting the schedule for presentation and adoption of the Local 571 yearly budget.
- 6) allowing reimbursement for meetings attended for any committee chairs who are not elected through their council.
- 7) changing the procedure for hiring Local 571 employees to allow for use of e-mail and 571 website notification.



## Our Fight Continues

Turning back decades of progress, Ohio has joined Wisconsin in attacking unions by passing SB5, which removed the collective bargaining rights of 350,000 Ohio public employees. Wisconsin Governor Scott Walker and Ohio Governor John Kasich have fought hard for legislation to eliminate workers' rights, and state legislatures across the country are considering similar bills.

Florida just passed damaging legislation masquerading as education "reform." Florida's Governor Rick Scott has signed into law the bill which his predecessor Governor Charlie Christ had wisely vetoed last year. It eliminates tenure for new teachers and uses financial incentives to currently tenured teachers to give up their tenure. Seniority will no longer be the basis for pay raises or a defense against layoffs. It defies logic to think that making teaching such a precarious career will attract the talented new teachers that we need.

This is obviously an effort to blame teachers' unions and collective bargaining for the fiscal crisis of many of our states.

AFT President Randi Weingarten pointed out the weakness of this point of view in a March 28 speech to the Commonwealth Club of San Francisco, citing the lack of correlation between states with bargaining rights and those with big deficits. Moreover, she said that collective bargaining actually can be part of

the solution in that "It can be a means to find creative ways to maintain or protect vital public services in the face of budget short-falls."

The fight will be waged again in Illinois, when the Senate Education Reform Committee will soon consider such proposals as the corporate-backed Performance Counts, which contains provisions similar to those in Florida. IFT was able to slow down this process in January, and we will continue to fight for Accountability for All, which is genuine education reform.

There has been some good news. Wisconsin's Circuit Court Judge Maryann Sumi issued a restraining order against the legislation curtailing collective bargaining there, which puts the bill on hold until May 23 unless the Wisconsin Supreme Court intervenes. In Indiana, Democratic state representatives defeated a push by Republican state representatives to enact "right to work" legislation. Also, many analysts and politicians now believe that anti-union candidates may be hurt by the right wing's miscalculation that unionized public employees would make an easy target.

It is now the crucial time to fight to save our hard-won rights.
